To set up your utilities in your name, please complete this form, **SIGN** (electronic signature is acceptable) and return to the City with a legible copy or photo of **YOUR PHOTO ID OR DRIVERS LICENSE**. If submitting this form in person, we can make the copy for you.

Our billing periods are the 16th to the 15th. Bills are processed and mailed approximately on the 22nd of each month, with a due date on the 15th of the following month. If not paid in full by the 15th, late penalties are applied, and a disconnection notice is sent.

The City does not require a deposit up front, or an application fee. We do charge a \$15.00 service fee when closing the account or processing a read request from the owner.
